**Curricular Aspects** 

Curricular planning is the mainstay of any higher educational institution. The College being affiliated to Bharathiar University depends to a large extent on the curricular framework and guidelines provided by

the university. The responsibility of the institution lies in academic planning and implementation of the curriculum by adhering to a flexible academic calendar and arranging and documenting the process of continuous internal assessment of students. Keeping in view academic planning, faculty members plan and execute their curricular, co-curricular and extracurricular activities through Academic Diary. The delivery of curriculum and implementation of various activities are regularly monitored by Academic Monitoring Committee. The quality of curriculum delivery and attainment of course objectives is ensured through internal assessment, seminar, practical assignments, students attendance etc. On the other hand, institutions maintained academic diversity by introducing new add-on courses with a minimum of 30 hours in tune with the emerging trends and local needs for curriculum Enrichment. The introduction of certificate course in Computer Application, Tally ace, Business Development Executive program, in last five years has enhanced the add on curriculum base. Teachers-students are involved in projects based curriculum along with research work, research paper-presentation, publications. Courses on professional ethics, human values and environment are included in each program to inculcate professional traits at the workplace. These are important cross cutting issues to address the students in transacting the curriculum. The project work based on Curriculum is carried out by students. The practical application of curriculum in the main stream of project work. Due weight age is accorded to the field projects / research projects / internships and value added courses for imparting knowledge, skill and real life problem solving ability.

Apart from issues of flexibility and diversity, the college collects the feedback on various curricular aspects from different stakeholders such as the Students, Alumni, Employer and Faculty using structured format. The feedback form collection is done through google form as a transparent mechanism. Stakeholders' expectations as coded in their feedback are an important input for initiation and sustenance. The suggestions, compliments are considered to improve the educational system from the perception of stakeholders.

#### **Teaching-learning and Evaluation**

Sree Narayana Guru College emphasizes a balanced approach between teaching and research, with specific strategies tailored to support students from various economic backgrounds. This approach ensures that the students receive adequate support and attention to enhance their learning outcomes. Faculty members combine traditional teaching methods with modern teaching pedagogy. Faculty prepare detailed lecture plans and maintain weekly logs documenting the content covered in classrooms. Feedback from students is actively sought to ensure that teaching remains student-centric. Students' feedback offers perspectives on the relevance and clarity of course content. It helps instructors ensure that the curriculum meets current educational standards and addresses the practical needs of students in their academic and professional pursuits. IQAC conducts effective Faculty Development Programs to improve the quality of teaching.

Information and Communication Technology (ICT) is integrated into the learning environment to ensure continuous access to educational resources and materials. Industrial visits and educational tours help the students to explore industrial knowledge. This approach supports independent learning and allows students to engage with course content at their own pace and convenience. To promote a broad intellectual outlook, students are encouraged to enroll in at least one value added course each semester that is related to their major area of study.

Students undergo continuous assessment through written examinations, class seminars, and assignments.

This approach ensures comprehensive evaluation of their understanding and progress throughout the semester. Students have the opportunity to pursue the valued answer scripts for internal tests, and efforts are underway to extend this provision to answer scripts of final examinations. This transparency adopts trust and accountability in the evaluation process. Bharathiar University employs a continuous assessment system. Answer scripts from these examinations are evaluated using a rigorous process to maintain fairness and accuracy. The university employs a double valuation system where two examiners independently assess each script. A third valuation may be conducted if there is a significant discrepancy between the first two evaluations. After the evaluation, a scrutiny and moderation process is carried out by the university to ensure consistency in grading and to address any discrepancies noted during the evaluation process.

#### Research, Innovations and Extension

The Research cell of the college encourages the faculty and students in their Research activities. The cell focuses on Research activities by providing necessary infrastructural setup at large including reputed Journals and Encyclopedias in the library and with well-equipped computer labs.

The Research Committee organized Experts and Invited Lectures to promote Research Culture and Innovation. Members of the Faculty have published 174 papers in UGC Care list Journals and Scopus. 40 Books / Chapters in Books / Papers in Conference proceedings have been published in the last five years. R & D Cell organizes National level Workshop on Research in Higher Education Institutions on various topics. Financial Assistance to attend and present papers, Seminars/Conferences/Workshop and Incentives to the research publications with a good impact factor.

IPR Cell conducts awareness programs for the students and Faculty Members to educate them on Intellectual Property Rights including Patents, Copyrights, Trademarks and Trade secrets. IPR Cell assists in documentation and filing of Patents and copyrights for innovations. Various laws and procedures that are presently available for protecting the IPs, products and Research works have been shared among the students. EDC identifies the students who are interested in becoming entrepreneurs and guides them to establish their startups.

The College is concerned about holistic development of the students and organizes extension activities to make them socially responsible citizens. NSS and Eco Club organizes extension activities to inculcate a sense of responsibility and humanity among the students. Rallies are conducted to spread awareness among the Public. The College has done a number of extension activities and became the role model for their students to be socially responsible.

The Institution has received remarkable awards and recognitions from Government organizations and Non-Government organizations for the splendid support rendered by the National Service Scheme, Nature Club for organizing Service programs for the village people in and around Coimbatore city. The College has signed MOU's to provide on the job training, internship, Project work and facilitates student / Faculty exchange and collaborative Research.

#### **Infrastructure and Learning Resources**

spread in 15 acres has luxurious greenery with wide biodiversity. The College Building consists of three floors with 8 blocks from A to H. College has 65 classrooms, 12 laboratories, Play Ground, Gymnasium, Open Air Auditorium, General Library, Department Libraries and canteen. College has a seminar hall named "Vivekananda Hall" and a conference hall. Seminar hall has audio visual facility and two guest rooms. College bus facility is available to various parts of Tamil Nadu and Kerala. The college has separate hostels for boys and girls. Internet facility is made available on campus through Wi-Fi. CCTV cameras have been installed in ladies hostel and in college campus. Public announcement system in the college is used for prayer and announcements. Fire safety systems are kept in various parts of the college. Ramp facility is available for disabled students. Ladies' toilet is equipped with a fully automatic sanitary napkin incinerator. College has water purifying systems, an herbal garden, three generators, a solar plant and Intercom facility. College has 328 desktop systems connected to uninterrupted power supply (UPS) with speed of 100Mbps. Institution has class rooms with LCD projectors and smart boards. College campus has a vast sports ground with Basketball Court, Football ground and facilities for indoor games and yoga practice. College has a separate Library with 6283 Square feet with the seating capacity for about 120 readers. Learning is powered by remote access to OPAC, E-resources and databases like N-List, DELNET and amenities like reading room, reference section and digital library. The library is fully automated with Integrated Library Management System (ILMS) supported by EASYLIB software. The library operates using the OPAC system for efficient cataloguing and retrieval of information. The College security operation is outsourced with three security guards. The college takes direct initiative in the maintenance and upkeep of infrastructure and support facilities. The Policy and Procedures of the College provide the basis for equitable allocation and efficient utilization of facilities based on the critical needs of educational, research and administrative activities.

#### **Student Support and Progression**

Sree Narayana Guru College has always been a student-centric institution. Student mentoring and support has been the primary focus of the college. Every class has a teacher assigned to counsel and mentor the students. Hostellers have access to their hostel officials at any time of the day and night.

During their stay, students can avail a number of support systems and services for information, academic and career guidance, financial, co-curricular and extracurricular activities. All departments have associations under the auspices of which students can interact with eminent academicians and scientists. Students can make use of the Grandhalaya, common library and departmental libraries for reference work, and computer and internet services for browsing. The scholarship section provides information on various financial support schemes. The Equal Opportunities Cell caters to the welfare of SC/ST students, which gives information about financial support to the students. The Placement Cell arranges for campus recruitment.

The college has a Grievance Redressal Cell, Anti-Ragging Cell and Internal complaints Committee. Girl students can address their grievances to the Internal Complaints Committee (which also addresses sexual harassment cases). Students in need of counseling have access to professional counselors.

SNGC Alumni Association plays a vital role in the Development of the Institution. Social Media platform is a powerful link which waves a bridge between the College and Alumni.

The Fine Arts Club of our College is very active which gives chances to students to showcase their talents. The students exhibit their talents in cultural during Inter collegiate ,inter-departmental competitions ,Cultural day, Annual day and in any other special occasion in the college.

The Physical Education department with the gymnasium, impressive courts and tracks provide a venue for sports and games. The Physical Education is established in order to guide the students in participating in various Sports events at State /National /International Levels. The Committee also provides Sports Scholarship to the eligible students as per the guidelines.

# Governance, Leadership and Management

The Principal is the Head of the institution. Principal is assisted by the Academic Council composed of Heads of various Department and Executive Manager for all academic and administrative matters. The Academic Council members express their views and suggestions for the smooth functioning of the college in the periodic meetings. This process ensures democratic academic decisions at all levels, as per the statutory provisions of the college.

The administrative machinery is well knit and there is adequate decentralization of various functions vested with the Heads of the Department, Executive Manager and Faculties. Being an Affiliated Institution, the examination cell is headed by Chief Superintendent. Examinations assisted by Exam cell faculty in-charge and the supporting staff. All the administrative functions come under the overall control of the Principal. Both the academic and administrative activities are under the purview of the Principal.

A culture of participatory management is practiced at all levels. At the department level, suggestions from all the faculty are considered for teaching-learning, and evaluation process as well as in general administration. Student representatives play a role in managing the departmental societies. At the Faculty level, representative members managing several auxiliary units such as laboratories and hostels collectively participate in administration and decision making. Constitution of various clubs and committees led to greater participatory management and decentralization.

The College has an Internal Quality Assurance Cell (IQAC) that plays a proactive role in reviewing the current status and evolves programmes, policies and suggestions to improve quality in teaching and research. The IQAC is constituted as per the NAAC guidelines. The prime task of the IQAC is to develop a system for conscious, consistent and catalytic improvement in the performance of the institution. It is a facilitative and participative voluntary system for quality enhancement by introducing suitable intervention strategies. It motivates the faculty to strive for quality improvement. Despite pandemic challenges, the series continued with national engagement and publication, enriching intellectual dialogue on campus.

The Sree Narayana Guru Youth Club upholds ethical values through programs based on Guru's teachings, fostering holistic development. The college's academic excellence is evident in its consistent high university ranks. Sports achievers receive significant fee concessions, complemented by intradepartmental competitions that nurture talent and recognize achievements.

The Centre for Sree Narayana Guru Studies offers certificate courses on his teachings and organizes pilgrimages to Sivagiri Mutt; engages in charitable activities.

# **Institutional preparedness for NEP**

1. Multidisciplinary/interdisciplinary:

Sree Narayana Guru College, Coimbatore is offering various programmes in Arts, Commerce,
Management and Science disciplines. The programmes offered in various streams to gain a multidisciplinary status for the institution. The programmes offered fall under CBCS (Choice Based Credit System) pattern in which the courses prescribed have specific credits. The courses are named as Core, Allied, Elective, and Skill Based, Practical, Foundation Course, Non Major Elective with specific number of credits to each course.

Almost all the UG Programmes and PG programmes have experiential learning in the form of Projects, Field visits, Study Tours, and Internships. To

sensitize the students to environmental issues and to make them eco conscious a course on Environmental Studies is included in the curriculum for all UG students. A course on Value Education with a special focus on the essential human and life values is also included in the curriculum. The scope of various programmes and the specific objectives of various courses ensure holistic development of the students. Being an affiliated institution, the college follows the procedures framed by the parent university regarding the entry level qualification needed for a programme, and duration of a programme /course. The institution is limited in enabling multiple entry and exits as the norms are decided by the university which approves each programme offered in the college. Students registering for research programmes will be encouraged to carry out multidisciplinary research that would help in finding out appropriate solutions for the current issues and challenges.

#### 2. Academic bank of credits (ABC):

ABC will allow students of undergraduate and postgraduate degree courses to exit the course and enter within a stipulated period. Being an affiliated institution, the college has less scope in taking initiatives to implement the ABC system. However, the institution will follow the procedures as framed and prescribed by the affiliating university. So far, the institution has not taken any measure to register under ABC. The senior teachers who serve the BoS at the University as Chairpersons / Members make representations regarding curriculum enrichment. Academic Bank of Credits shall provide to every student the facility to open a unique or individual Academic Bank Accounting digital form; and the account holder shall be provided with a unique ID and access to the Standard Operating Procedure (SOP). The ABC Regulations intend to give impetus to blended learning Mode, allowing students to earn credits from various HEIs registered under this scheme and through SWAYAM, an online repository of courses. Regarding pedagogy, the teachers are always encouraged to try out new strategies that are learner centric. In teaching learning, besides the prescribed text books and reference books, the teachers have the liberty to access any other book or material with content related to the topics prescribed in the syllabi. The teachers are also encouraged to provide additional resources / reading materials.

Regarding assessments, both internal and external, the assessment criteria prescribed by the affiliating university is strict.

# 3. Skill development:

Soft Skill enhancement is achieved by conducting special programmes on Soft Skill development with experts in the field. Besides teaching the curriculum, the institution takes various initiatives to offer value based education. Life Skill Programmes are conducted to promote life values. Important days like Republic Day, Independence Day, Constitutional Day, Voter's Day, Environmental Day, National Integration Day, and many other important days / events of national importance are celebrated to promote national integration. Competitions are conducted on such occasions to motivate the students and to inculcate positivity in the young minds. Every student admitted in the college at the Undergraduate level is supposed to enroll in any of the cells or clubs like NSS, YRC, RRC, Eco Club, etc, which is mandatory for graduating. Life skill programmes like Yoga, Mediation, Women Safety, Health and Hygiene, etc, are organized with the services of industry experts who offer hands-on training.

4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):

India is a treasure trove of culture, developed over thousands of years and manifested in the form of arts, works of literature, customs, traditions, linguistic expressions, artifacts, heritage sites, and more. In particular, languages influence the way people of a given culture speak with others, including with family members, authority figures, peers, and strangers, and influence the tone of conversation. The tone, perception of experience, and familiarity inherent in conversations among speakers of a common language are a reflection and record of a culture. Culture is, thus, encased in our languages. Since its inception the college has been promoting the culture and heritage of our nation. The elective courses prescribed in the programme focus on Indian tradition, culture, philosophy, and knowledge system. Being a higher learning institution, the college adopts English language as the medium of instruction. The institution has also observed the difficulties faced by students with the use of English for classroom instruction. Taking the socioeconomic, cultural, and linguistic backgrounds of the students into consideration the teachers are also encouraged to go with a bilingual method of teaching. It is also found

that the students' receptive skills have been enhanced with bilingual mode of delivery. As most of our students hail from rural backgrounds and for a better understanding of the subjects taught bilingual method of delivery is encouraged in almost all programmes.

# 5. Focus on Outcome based education (OBE):

Outcome-based education is a system where all the parts and aspects of education are focused on the outcomes of the course. The students take up courses with a certain goal of developing skills or gaining knowledge and they have to complete the goal by the end of the course. There is no specific style or time limit of learning. The student can learn as per their choice. The faculty members, moderators, and instructors guide the students based on the target outcomes. The programmes and courses prescribed in the syllabi have specific programme and course outcomes. In curriculum design and development sufficient representation is made to the affiliating university through BoS. More courses with experiential learning is recommended to be included in the syllabi. Skill based courses, Job seeking courses, and Project works are a part of our syllabi to make our education outcome based. The teaching learning process is also more learner centric in recent times and the institution has witnessed a shift from traditional methods of teaching. Students' assessment is made through continuous internal assessments like assignments, seminars, peer team teaching, group discussions, and quizzes.

## 6. Distance education/online education:

Being an affiliated institution, the college offers only regular programmes. No programme is offered through online or distance mode. In its educational journey, the college has witnessed many phases of the teaching learning process. Earlier, the most popular method used for teaching was chalk and talk method. In recent times, the education industry has been completely digitized with the advancements in Science and technology. Our college promotes the use of ICT in the teaching learning process. The infrastructure and ICT facilities of the college are continuously augmented by our management to meet our existing demands. The post Covid scenario has increased the use of many virtual platforms in teaching learning. Both the teacher and student community are now comfortable with many online tools for teaching. During the pandemic the institution has made the best use of blended learning.

Online exams, online quizzes, webinars, online assignments along with regular physical classes have been tried by the institution as a part of blended learning.

Assessment forms an integral part of effective curriculum delivery. The internal exam system in educational institutions typically consists of three main components: I Internal Exam, II Internal Exam, and Model Exam. Its primary purpose is to identify students' strengths and weaknesses early on, allowing educators to provide timely interventions and support as needed. The II Internal Exam typically takes place later in the academic term or semester. It assesses students on broader range of curriculum content covered throughout the term. Its objective is to evaluate students' overall grasp of the subject matter as they approach the end of the instructional period. The Model Exam, also known as a mock exam, is designed to simulate the conditions of the final external examinations. It occurs towards the end of the academic term or semester, before students sit for the actual external exams. Its purpose is to familiarize students with the exam format, assess their preparedness for the final assessments, and help them identify areas needing further revision. Educators use the results of it to provide targeted feedback, refine teaching strategies, and guide students in their final preparations. Overall, the internal exam system allows educators to monitor students' progress

#### 2.5 Evaluation Process and Reforms

#### 2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

#### **Response:**

#### Internal Assessment:

For internal assessments, the college abides by the standards of fairness and transparency established by Bharathiar University. The organization follows the University's instructions. The university has complete control over the testing procedure, including question paper preparation, test supervision, answer sheet evaluation, and result announcement. The students receive advance notice of all relevant information. During the initial years of the assessment period, the ratio of external to internal assessment was 75:25. Now it has been revised to 50:50. The internal examinations are controlled by the College Exam Cell. Additionally, answer scripts are evaluated by examiners at the central evaluation center of Bharathiar University. The evaluation process follows the guidelines of Bharathiar University for both Continuous Internal Assessment (CIA) and End Semester Examination. Every semester, Internal Assessment Tests and Model Examinations are conducted and used for awarding marks. The timetable for CIA is formulated and communicated to students well in advance and is noted in the academic calendar. Seating allotments are displayed on the notice board. Every semester, the College Academic Council conducts and monitors examination-related matters and compiles invigilation duty charts, which are duly assigned.

#### Provision for Internal Examination Grievances:

The concerned faculty issues the answer sheets of internal examinations to students and collects their grievances, if any. If a student feels that the marks scored for any paper are not as expected, they can opt for revaluation through a letter within seven days of the declaration of results. The action taken on the grievances is communicated to students within a stipulated time period. Students can review their graded answer sheets and report any discrepancies to the concerned faculty members and the Head of the Department (HoD). The HoDs report the grievances to the academic committee. If resolved, the students are informed; if not, the issue is forwarded to the Principal for further action. Students who fail to attend

an internal examination due to medical or unavoidable circumstances are permitted to write the exam on another day after submitting the relevant proof. Students may submit their grievances to the department HoDs.

#### External Assessment:

The exam cell will follow the guidelines and rules issued by Bharathiar University for conducting endsemester examinations. These examinations are conducted and controlled by the University. If students have any problems, the Principal will communicate with the Controller of Examinations at Bharathiar University regarding the students' grievances. Student grievances related to external examinations at the university level are addressed through a proper channel. This includes obtaining photocopies of the evaluated answer scripts, re-valuation, on payment of the prescribed University fee. Feedback on the University question papers, particularly for out-of-syllabus questions and discrepancies, is provided to the University by the concerned faculty members through the proper channels.

#### Provision for External Examination Grievances:

Any grievances represented by the students to the course faculty member and Heads of Departments are forwarded to the Principal. The Principal will then forward these grievances to the University. Whether the grievances are resolved or not, the outcome will be communicated to the students. After the results are published, students can apply for revaluation, re-totalling, and transparency if there are any discrepancies in their scores. The University also offers supplementary exams to final-year students who have a single arrear paper in their final semester exam.

The college has developed pragmatic mechanisms to measure the attainment of Programme Outcomes (POs), Programme Specific Outcomes (PSOs), and Course Outcomes (COs). Continuous assessments are conducted through seminars, class tests, quiz programs, and interactions with faculty members to measure course outcomes.

#### Programme Outcomes (POs):

Programme Outcomes are statements reflecting the knowledge, skills, and attitudes that students should possess upon completion of a degree. POs describe the general expectations of graduates from a particular program and the proficiencies attained after completing their degrees. Upon admission, faculty members provide details with students regarding the curriculum and Programme Outcomes for each program offered by Bharathiar University.

#### Course Outcomes (COs):

The objective of creating Course Outcomes (COs) is to categorize the applications, knowledge, and abilities that students have acquired. COs are created in accordance with the goals of the program. COs provide as an example of what students should have understood and learned by the completion of the course. The institution evaluates students' performance in meeting program and course outcomes using a variety of techniques, including internal reviews and mock tests. The Institute is affiliated with Bharathiar University and follows the norms prescribed by the University. The Institute imparts Outcome-Based Education to the students and evaluates Programme Outcomes, Programme Specific Outcomes, and Course Outcomes. Evaluation of course outcomes elucidates the learning level achieved between course objectives and program objectives. This clearly indicates whether or not the students are able to accomplish the course outcomes. The evaluation of students' progress towards the Course Outcomes (COs) and Programme Outcomes (POs) is based on their responses to a series of assignments, continual internal assessments, and model exams. The university conducts the end-semester examination for both theory and practical courses, evaluating theoretical and practical knowledge, skills, and performance obtained through the study of the curriculum. Attainments of COs are determined through University examination results. COs are evaluated by assigning class seminars, internships, and projects to students that provide them with practical experience, develop new skills, hone their problem-solving ability, and increase career prospects. The Programme Outcomes are evaluated by examining students' advancement during their academic journey. This evaluation is based on numerous factors, with the cumulative grade earned by the students being a key factor in determining the realization of Programme Outcomes (POs) for each course. By analysing students' grades together with other assessment methods such as assignments and projects, a comprehensive assessment of their progress and attainment with respect to the POs is achieved.

#### **Response:**

The course outcomes attainment is obtained from the performances made by the student in internal Assessment and End Semester University examinations. The Internal Assessment includes CIA examinations and assignments. Bharathiar University process of Continuous Internal Assessment includes three internal exams. First at the end of unit 1 and partial of unit 2, Second at end of balance units 2 and 3, in Third model exam all units together. The internal mark calculation is also done with assignments or seminars depending on UG or PG courses. The External Assessment is done by the end-semester University examination, conducted by the University.

The fulfilment of the course outcomes is verified through the use of both direct and indirect evaluation techniques. Assignments and seminars are originally assigned in each semester under the direct methods to assess the student's ability to absorb the material independently. In order to meet the course

objectives, the college uses both direct and indirect evaluation techniques. Different levels of the CBCS pattern are integrated into the question paper for both internal and external exams. To gauge a students topic knowledge, model tests and continuous internal assessment are administered. The response scripts are carefully assessed without favouritism or bias. In order to evaluate indirect course outcomes, feedback from stakeholders is gathered, with a focus on students, teachers, and alumni.

Evaluation of Practical subjects is also by both Internal and External Examiners who are appointed by Bharathiar University. The Academic Monitoring Committee monitors the evaluated paper and verifies the mark entries for all the three Continous Internal Assessments. The committee also verifies the assignments submitted by the students and also monitor the evidences of seminars handled by the students. The committee also monitors the Continuous Internal Assessment's mark uploading process to the Bharathiar University Exam portal. The hard copy of the uploaded Continuous Internal Assessment marks is maintained in the concerned department for further verification or updations. After the University Theory Examinations, the college gets order from the Controller of Examinations appointing faculty members for Central Valuation. The answer scripts are being evaluated by the appointed faculty members in the central valuation after which the results will be published.

The process of Analysis is done by the faculties of the college for both Internal and External Marks to check the attainment of COs and POs. The result analysis is reviewed in the academic council meeting and submitted to the management as report on exam evaluation. The staff will be asked to submit the reason for poor results and if so are asked to conduct remedial classes to improve the students performance and to attain the target of maximum pass percentage.

#### **Response:**

Sree Narayana Guru college, a Premier Postgraduate and Research Co-educational Institution came into existence in 1994. Campus which is spread over 15 acres has luxurious greenery with wide biodiversity. The College Building consists of three floors: ground floor, first floor & second floor with 8 blocks from A to H with 65 classrooms and 16 laboratories for academic purposes. The Institution has well equipped Classrooms, Smart rooms, Smart Class Rooms, Faculty rooms, Play Ground, Gymnasium, Open Air Auditorium and a spacious Library. Institution has eight Computer Labs, three Microbiology labs, two Biochemistry labs, two Biotechnology labs, one Psychology lab for conducting Practical and Research activities. Each laboratory has an adequate number of equipment facilities and is well equipped with equipment such as UV Spectrophotometer, Phase Contrast Microscope, PCR Thermocycler, Microcentrifuge, Vernier Chronoscope, Bhatia Performance Test of Intelligence. The main Library complemented by department libraries offers a vast collection of books. Books on teachings of Sree Narayana Guru, philosopher, spiritual leader and social reformer in India which are available in different languages helps the students to follow the path of the great saint. The college is named after this great saint, Sree Narayana Guru. The college has a Knowledge Centre and Digital Library each with 20 Computers used by students, research scholars and faculties. College has a seminar hall named Vivekananda Hall which is spacious with audio visual facility and two guest rooms and a conference hall. Both the halls are used for conducting seminars, conferences, workshops and club and cultural activities. The college has a spacious and hygienic canteen. College bus facility is available to various parts of Tamil nadu and Kerala. College has a general Library with a total area of 6283 Sq. feet. The college has separate hostels for boys and girls. Internet facility is made available on campus through Wi-Fi. Internet facility is available with 100mbs bandwidth. 13 CCTV cameras are installed in the girls hostel and 75 CCTV cameras in campus. Public announcement system in the college is used for prayer and announcements. Fire safety systems are kept in various parts of the college. Biogas plant in college is used to generate biogas from biowaste which is used in the college girls hostel. Ramp facility is available for disabled students. Sick room and wheelchair in the institution is used by the needed students. Ladies restroom is equipped with a fully automatic sanitary napkin incinerator. College has nine water purifying systems for staff and students. Cement benches in the college garden are one of the favorite places of students during their leisure time. Herbal garden and the vast number of plants of our college help to teach students about environmental education and medicinal plants. An uninterrupted power supply is available through three generators of 125kVA,75kVA and 25kVA. A solar plant of 10kVA capacity is also constructed towards the usage of renewable energy. Intercom facility of the college makes the communication between various departments, gate, administrative sections, canteen etc. faster and more

Library is automated with digital facilities using Integrated Library Management System (ILMS), adequate subscriptions to e-resources and journals are made. The library is optimally used by the faculty and students

#### **Response:**

Sree Narayana Guru College have separate Library in the Ground Floor with 6283 Square feet with the seating capacity for about 120 readers. The library is equipped with 27721 books (17664 titles), 1250 Back Volumes, 1570 CD/DVDs, 62 Journals, 16 Magazines, and 8 Newspapers. The Central Library has various sections that support the content beyond syllabus. Learning is powered by remote access to OPAC, E-resources and databases like N-List, DELNET and amenities like reading room, reference section and digital library. Digital Library with internet connectivity enables access to digital content like Video Lectures, E-Journals, E-Books, Projects, PDF Notes, PPTs and Course Material Files. The Library is well equipped with a reading capacity of 150 readers. The library provides provision for

students to refer previous semesters question papers of Bharathiar University for preparing their semester examinations. The library is fully automated with Integrated Library Management System (ILMS) supported by EASYLIB software. EASYLIB software facilitates acquisition, cataloging, circulation, administration, E-gate register, and reporting circulation status and overdue of books. Library offers Remote Access to E-resources and online databases of INFLIBNET-N-List, E- Shodh Sindhu. Digital Library with 20 computers and internet facility support access to online resources 24×7.

The Library is fully automated through EASYLIB 5.0. The software has facilities for the better management of the Library viz, reviewing the library Membership, Circulation, Acquisition and Report generation. The library is restocked every year and as required, for providing sufficient learning resources for students. Access through the gate is facilitated by two barcodes and laser scanners, and all processes, including book lending and returning, are seamlessly managed within the automated system. The in and out time is also recorded through this system. The library operates using the OPAC system for efficient cataloguing and retrieval of information. Notable features of the software include: Issue and return of books, reservation of books, availability of books, book location, Gate entry etc.

The UG can avail 2 books per issue and PG can avail 4 books per issue and the books should be returned within 15 days of issue. After the due date, the students may renew the issued books. The library can be accessed anytime between 9 am and 5 pm on all working days. The library also preserves the Ph.D. dissertation of the faculty, thesis and project works of the students and scholars for reference.

The Library have the Sree Narayana Guru Readers Corner: A Readers Corner containing the books on Sree Narayana Guru is available in the College central Library which stocks books written by Sree Narayana Guru in languages such as Malayalam, Tamil and English. Students of our College come to know more about the preaching of Sree Narayana Guru through these books. The reading corner not only contains books written by Sree Narayana Guru but also books written by his disciples.

The Library Advisory Committee consists of staff and students members from all the streams. The main objective of the Committee is to increase self learning among the students and make them lifelong learners.

#### NEP Implementation:

The programmes offered fall under Choice Based Credit System pattern. ABC: Being an affiliated institution, the college has less scope in taking initiatives to implement Academic Bank Credit System. The senior teachers who serve the BoS at the University as Chairpersons / Members make representations regarding curriculum enrichment. The College adopts English language as the medium of instruction. On considering the linguistic background of the students the college encourages the teachers to go with bilingual method of teaching. based on the prescribed outcomes. Distance/ Online education: The College offers only regular programmes. No programme is offered through online or distance mode.

Performance Appraisal System:

The purpose of the performance evaluation system is to allow faculty to have a clear understanding of their current performance. The evaluation will guide faculty toward performing in furtherance of the missions, strategic objectives and goals of the college and its departments. The process which includes a faculty self appraisal form and a student feedback on teaching form provides faculty with meaningful information and recognition of strengths, weaknesses, and recommendations for improvements.

The college implements an academic and administrative performance appraisal in a structured form

every year to evaluate the academic skills and performance of the faculty. Faculty performance is periodically reviewed on various criteria such as teaching and guiding students in the undergraduate, postgraduate and doctoral programmes, carrying out research, publishing papers in scholarly journals, organizing national / international workshops / seminars / conferences / conventions / conclaves.

A feedback form is prepared and at the end of every semester, the responses from the students are collected. Students are asked to fill up the feedback forms and rate the performance of their teacher on various parameters, on a five point scale and give their opinion against each parameter. The parameters include depth of knowledge and concept clarity, presentation of topic, regularity and punctuality, availability of teachers for solving subject difficulties, completion of the syllabus, attitude towards students etc. They were also free to give their suggestions and opinions in the space provided in the form.

#### Staff Welfare Measures:

Sree Narayana Guru College effectively implements the welfare schemes for the teaching and Non teaching staff to create a harmonious and conducive work environment for effective functioning of all the faculty and staff members across the college. The college has adopted measures to promote the welfare of the employees. The College makes arrangements for availing Provident Fund, ESI, , Maternity Leave. The College encourages professional development by giving permission to attend faculty development programs, workshops, conferences, orientation programmes and refresher courses, short term courses, short term training programs etc. for the career development and progression of the teaching as well as non-teaching staff. Financial support is also provided towards membership fees of professional bodies. **BEST PRACTICE - 1** 

- 1. **Title of the Practice:** "Extension Activities"
- 2. The Context:

Initially, our Extension Activities started in our pioneer adopted village, C.G. Pudur, which is inhabited by rural residents. Following the Unnat Bharat Abhiyan (UBA) guidelines set by the Government of India, we have adopted five additional villages in Pichanur panchayat namely Veerappanur, Rangasamudram, MGR Nagar, Pattamparai and Kommandamparai. This initiative aims to educate rural people in neighbouring areas of the Institution. By adopting these villages, the college assumes responsibility for their overall development. Various awareness programs, rallies and general medical camps are organized to ensure the people's health and educate them on current social issues. School students in the adopted villages were given career guidance and basic English grammar classes through the extension activities. The specific extension activities include teaching the importance of water conservation, environment protection, organic waste management, alternative energy conservation etc.

#### **Objectives of the Practice:**

- To educate inhabitants about education policies and impart knowledge on mental health, physical health, hygiene and epidemic diseases.
- To involve students and faculty from Higher Educational Institutions (HEIs) in identifying rural development issues and finding sustainable solutions.
- To identify, select and implement innovative technologies tailored to the villagers' needs.
- To enable HEIs to assist in the effective implementation of various government schemes and programs. **The Practice:**

This practice focuses on the comprehensive development of the village, covering mental and physical health, education, employment and general knowledge. The college organizes a range of programs, each managed by different departments, clubs and committees. In the UBA adopted villages, medical camps are held to build rapport

with the villagers, followed by socio-economic surveys were taken by the students. Participatory Rural Appraisal techniques are employed with support from experts to gather qualitative data. Students from each department engage to empower the villagers by various extension activities like door-to-door canvassing, performing street plays, distributing awareness pamphlets and conducting rallies on various social issues. General Medical Camps are also conducted for the villagers' well-being. Activities marking National Days of importance are held at the village Government Schools, benefiting the students.

#### **Evidence of Success:**

College students and staff visit the adopted villages regularly. They organize street plays, awareness campaigns, rallies, lectures and poster presentations. Villagers gain knowledge about mental and physical health care, education and government policies, which enable them to lead healthy and harmonious life. Many children joined schools and school children are learning to communicate in English. The villagers are paying more attention to their health and health-related habits. The impact is also evident in our students, who benefit from their involvement in community services and societal well-being.

#### **Problems Encountered:**

Initially, it was challenging to make the villagers understand the importance of education and health care.

Through various awareness programs, we highlighted the necessity of these aspects and the challenges of living in a competitive world. Identifying five villages under the UBA scheme was also difficult. After considerable effort, the District Authority finally approved our selected villages under the Pichanur panchayat.

#### **Resources Required:**

- A community hall with good infrastructure to promote civic knowledge and skills.
- Adequate financial support for carrying out the extension activities.
- Collaboration with health care providers to offer affordable medical care.
- Increased collaboration with community and civic organizations.

- 2. Objectives of the Practice:

Sree Narayana Guru Commemorative Lecture Series, initiated by SNGC in 2019, serve as a platform for interdisciplinary discourse on contemporary topics by featuring expert speakers from diverse fields. The college organizes this annual lecture series for faculty members, students and research scholars to facilitate dynamic academic debates and the exchange of innovative ideas in arts and sciences. This series aims to enrich the intellectual knowledge within the student community and emphasize the institution's commitment to holistic education and intellectual curiosity.

#### The Context:

Since the Institution's Silver Jubilee year and the installation of the Panchalokha Statue of Sree Narayana Guru on 25th August 2019, the lecture series has been held annually in the month of August. The series commemorates Sree Narayana Guru's preachings and provides contemporary scientific insights, reflecting his saying, "Progress through Education." The August 2022 series, held over seven days and featuring fourteen sessions, underscores SNGC's dedication to intellectual growth and societal awareness through global perspectives on Guru's teachings.

The seven-day Commemorative Lecture Series on 'Sree Narayana Guru' in August 2022 features fourteen sessions covering various topics, including global perspectives on Sree Narayana Guru's teachings, block chain technology, climate change's impact on biodiversity and ecofeminism. Eminent Speakers bring a wealth of academic and practical experience to enlighten the students through interactive presentations and discussions.
